<u>Patti Evans</u> was born and grew up in Huntington, West Virginia. In her own words, "I received my undergraduate elementary education degree and graduate degree in Reading Education at Marshall University in Huntington, WV. Yes, that is the **We are Marshall** school that the movie was based on. I was a freshman the year of the plane crash and my husband played on the freshman football squad that year. Fortunately, the freshman team did not travel with the varsity back in those days. At Marshall, I was a member of Alpha Xi Delta Sorority.

I met my husband, Mark, at Marshall and we were married in 1977 in WV. We lived there for a few years before moving to Bartlesville, OK where my husband was working in the oil and gas business with Phillips Petroleum. After living there for 11 years we moved to Clear Lake, TX with my husband's company. Then we were moved back to Oklahoma after a few years and remained there another 7 years. In January 2001 we moved to San Antonio with my husband's job.

Mark and I were blessed to have one daughter, Kathleen, but sadly we lost her in 2009 at the age of 22 in a car accident in Colorado, where she was going to college. We have many great memories that we cherish of her and our house is filled with her art work which was her passion and what she was studying in college.

Our extended family lives back east. I have one sister that lives in Raleigh, NC and Mark has 2 brothers, one that lives in Ohio and the other lives in Georgia right outside Atlanta.

I am still adjusting to retirement and getting involved in other activities. I volunteer one day a week at the Canyon Ridge Library and last school year, I tutored a couple of hours a week working with some Kindergarteners and First Graders at the same school. I am also starting to do some scrapbooking with all my pictures. I am enjoying taking part in the NSARTA Book Club. This fall, I am joining a Bible Study at our church. Mark and I are members of St. Thomas Episcopal Church.

I joined NSARTA last fall after retiring, having taught for 43 years. The last 15 years I taught in NEISD at Roan Forest and Canyon Ridge Elementarys. Prior to moving to San Antonio, I taught in Huntington West Virginia, Bartlesville Oklahoma and in Clear Lake, Texas. I have enjoyed becoming a part of the NSARTA group and meeting many new people this past year."

The more we know about one another, the closer we become as a unit. Our hearts definitely go out to you at the loss of your precious daughter.

Klarita Kay Kelley was born in Pauls Valley, Oklahoma on May 22, 1937. In her own words, "My mother, Bertha Forehand Keltner, taught school in a one room school building (grades 1-12) in the small community of Lone Hill. The family moved to the small town of Lexington, Oklahoma but when I was 10, my mother decided to move to Texas. In those days teachers in Oklahoma only were paid 9 months of the year and students were required to buy their textbooks. What a great move it was. Today teachers in Oklahoma are the second lowest paid in the U.S. Of course, by age 10 I had already decided I would never be a teacher. We moved to Flour Bluff just outside of Corpus Christi where we lived in a teacheridge on the school campus so I was surrounded by educators and educator's children. My resolve: NEVER become a teacher.

After graduating from High School, I attended East Texas Baptist College in Marshall, Texas. My best memory of that year is the when we girls went to Shreveport to the Louisiana Hay Ride. There we heard a young man just starting out in country music. We agreed he was a good singer but he was going to have to change that weird name. He did not change his name and girls everywhere went crazy over him. Elvis Presley!

INTERRUPTION: At the end of year my brother graduated from High School. I returned home to work and go to night school. In those days if a family did not have the money to support two college tuitions, the money for full time needed to go to the son so he could support a family. I then met a University of Corpus Christi football player. Within a couple of months we devised our own plan. I would work until he graduated and then I would get my degree. This three year plan turned into a 6 year plan. Since it was before the PILL, he received his degree witnessed by his wife and two children with another on the way. His first job, teaching History and coaching, took us to Sinton, Texas. Here we stayed for 22 years. We lived in the country, raised chickens, hogs, and sheep for the county show. Had horses and belonged to the Texas Youth Rodeo Association, participating in youth rodeo across the state. I had returned to school and gotten my degree in the early years, graduating from A&I Kingsville. I taught American History, Speech and Drama. I substituted for 6 years before getting my degree and during that time I learned to love teaching, especially at the Junior High level.

INTERRUPTION: I am now 53. Children are all married and I have 4 grandchildren. I became a grandmother at age 40. I was 20 when I had my first child and my first child (Cindy) had her first at 20. I had a bumper sticker that said "If I knew Grandchildren were this much fun, I would have had them first". After 33 years of marriage my husband and I parted ways. I found myself on 150 acres in a small town. I don't like to play bridge, go to showers, or local athletic events. For the first time in my life, I had the opportunity to chart my own course. I decided to trade rodeos, country music, and country dances for cities with classical music, ballroom dancing, art exhibits, and shopping 15 minutes away. I just had to become more marketable in my career. I enrolled at Southwest Texas University full time and got my Masters as a Special Education Diagnostician. College was so much more fun at 53 then it was at 18. I began working at Edgewood ISD. Another unique experience to learn about different cultural norms in yet another environment.

INTERRUPTION: Retirement. Yes retirement. Since I started my education career later in life, I needed to finish my 40 quarters of Social Security. I could do this by contracting back to a school in need of Diagnostician services. This took me to Del Rio, Uvalde, Cuero, and the Coastal Bend. Another awakening experience to see the vast differences in ISD services delivered. When I stop to muse over my INTERRUPTIONS large and small I would not change a thing. Every unique interruption opened the door to a new experience. God must have had a plan. He just did not follow the timeline I originally planned. Thank you God. I love my life!"

As we prepare for the new NSARTA year and November election, we must become informed on the issues that apply to us.

First, we need to focus on the TRS Pension Fund. Many of us have not received an annuity increase since the 90's. A 13th check was given in 2008/09 to some retirees. Our TRS Pension Fund must be actuarially sound. The State's contribution must be increased or else your buying power will continue to weaken.

Secondly, The TRS Board left Aetna for Humana last January. For many this has been a nightmare. Humana makes it very difficult on the members, as well as the doctor's business

office. Hopefully in another year the TRS Board will make a better choice in our health insurance.

Finally. We must support funding for public education. Many charter schools are being created and one of our school district's enrollment was affected. We must vote for those candidates that support our issues. Our letter writing will begin once we know who has been elected.



Your new card will have a new Medicare Number that's unique to you, instead of your Social Security Number. This will help to protect your identity.

YOUR NEW CARD WILL LOOK LIKE THIS:



3 things to know

- 1. Your new card will automatically come to you. You don't need to do anything as long as your address is up to date. If you need to update your address, visit your My Social Security account.- Opens in a new tab
- 2. Once you get your new Medicare card, destroy your old Medicare card and start using your new card right away.
- 3. Your new Medicare Number is a unique combination of numbers and letters. Your new number uses numbers 0 thru 9. The letters S, L, O, I, B, and Z are never used.

Watch out for scams

Medicare will never call you uninvited and ask you to give us personal or private information to get your new Medicare Number and card.

Scam artists may try to get personal information (like your current Medicare Number) by contacting you about your new card.

If someone asks you for your information, for money, or threatens to cancel your health benefits if you don't share your personal information, hang up and call us at 1-800-MEDICARE (1-800-633-4227).
